

## REORGANIZATION MEETING

### MILTON BOROUGH COUNCIL

January 4, 2010

The meeting was called to order by Mayor Nelson with the following Councilpersons in attendance: Mr. Budman, Mrs. Meckley, Mr. Shearer, Mr. Barr, Mr. Davis, Mr. Reedy, and Mrs. Ulmer. Also in attendance were Attorney Benion, Doug Diehl, Chuck Beck, and Shelly Wood.

Following the Pledge of Allegiance and invocation, Mayor Nelson asked District Justice William Kear to administer the oaths of office to the newly elected councilpersons – William Barr, Richard Specht, and Charles Swartz. Mr. Kear then swore in re-elected Mayor Nelson and newly elected Fire Department Officers – Chief Brad Gaugler, Assistant Chief Joey Stump, and Deputy Chief Eric Goodbrod.

Election of Council President: Mr. Budman nominated Mr. Reedy for President. With no other nominations, Mrs. Meckley moved that the nominations be closed. All were in favor of this nomination, and Mr. Reedy was elected President of Borough Council for a two-year term. Mr. Reedy abstained.

Election of Council Vice President: Mr. Barr nominated Mrs. Meckley for Vice President. Mr. Shearer nominated Mr. Budman for Vice-President. Mr. Davis moved that the nominations be closed. At this time, a roll call vote had the following results:

Mrs. Meckley – In favor were Mr. Barr, Mr. Davis, and Mr. Swartz. Opposed were Mr. Shearer, Mr. Budman, President Reedy, and Mr. Specht. Mrs. Meckley abstained.

Mr. Budman – In favor were Mr. Davis, Mrs. Meckley, Mr. Shearer, Mr. Reedy, Mr. Swartz, and Mr. Specht. Mr. Budman and Mr. Barr abstained.

With the results of the roll-call vote, Mr. Budman was elected Vice-President of Council for a two-year term.

Mayor Nelson turned the meeting over to President Reedy.

Council Vacancy – 3<sup>rd</sup> Ward – This item was tabled for the next Council meeting.

Appointment of Chairperson Pro-tem: On motion of Mr. Budman, seconded by Mr. Shearer and carried, Council appointed Mrs. Meckley as Chairperson Pro-tem.

Appointment of Manager, Secretary/Treasurer, Code Enforcement/Zoning Officer, and Solicitor: On motion of Mr. Barr, seconded by Mr. Specht and carried, Council reappointed Chuck Beck as Borough Manager, Shelly Wood as Secretary/Treasurer, Doug Diehl as Code Enforcement/Zoning Officer, and Robert Benion as the Borough Solicitor. All re-appointments are for a two-year term.

Appointment of Council Committees: President Reedy tabled this action for the following council meeting.

Appointment of Vacancy Board Chairman: On motion of Mr. Barr, seconded by Mrs. Ulmer and carried, Raymond Callenberger was appointed Vacancy Board Chairman.

President Reedy congratulated and welcomed all new members to Council.

There being no other business to be considered at this meeting and on motion of Mrs. Meckley, seconded by Mr. Barr and carried, the meeting adjourned at 5:19 p.m.
