MILTON BOROUGH COUNCIL MEETING

February 24, 2016

The meeting was called to order with the following Councilpersons in attendance: Mr. Specht, Mr. Budman, Mr. Cyphers, Mr. Keiser, Ms. Fawess, Mr. Shearer, Mrs. Meckley, Mr. Walker, Mr. Farr, Mr. Budman, and Mr. Swartz. Minutes: On motion of Mr. Cyphers, seconded by Mr. Walker and carried, Council approved the minutes from the February 10, 2016 Council meeting.

Report of the Borough Manager: Mr. Beck had no report.

Report of the Mayor: Mayor Nelson had no report.

Report of the President of Council: President Budman had no report.

Report of the Chief of Police: Chief Zettlemoyer reported that the new cruiser will be going in for graphics on Monday. He also stated that informant is working on developing a patch to allow e-citations to communicate with the RMC system.

Report of the Public Works Director: Sam Shaffer reported that on 2/15/16, the crew plowed and salted all streets. They also cleared snow from all borough sidewalks. He also reported that the open bay to the pole barn is now complete. The crew has replaced 75 stop signs, 20 one-way, 4 yield and 10 Do-Not-Enter signs. All numbered streets signs $1^{st} - 4^{th}$ Street have been replaced. The 1998 Bucket Truck has been fully serviced and repairs made to the body.

Report of the Fire Chief: Fire Chief Stump reported 23 calls in February with an average of 11 volunteers. There have been 3 training sessions this year and two new members sworn in. .

Highways and Protection to Persons and Property:

General Government and Recreation:

- A. On motion of Mr. Walker, seconded by Mr. Farr and carried, Council adopted Amended Ordinance #1203 pertaining to definitions in Borough Ordinances by adding definitions for electronic smoking devices and smoke or smoking.
- B. On motion of Mr. Walker, seconded by Mr. Farr and carried, Council adopted Ordinance #1202 pertaining to prohibiting tobacco smoking on all parks and recreational areas, including parking lots pertaining thereto owned by the Borough and prescribing penalties for violations thereof.
- C. Research the feasibility of a Main Street Manager.

Finance, Health and Sanitation

A. On motion of Mr. Shearer, seconded by Ms. Cyphers and carried, Council approved paying the bills from General Fund, Reserve, Payroll, Community Pool, Liquid Fuels, and Cemetery accounts in the amount of \$108,107.24.
