

REORGANIZATION MEETING

MILTON BOROUGH COUNCIL

January 5, 2026

The meeting was called to order by Attorney J. Michael Wiley with the following Councilpersons in attendance: Mrs. Meckley, Ms. Fawess, Mrs. Mabus, Mr. Derr, Mr. Walker, Mr. Scheimreif, Mr. Swartz, Mrs. Moralez, and Mr. Moralez. Also, in attendance were, Alec Klingler, Jennifer Foust, Mayor Aber, Sam Shaffer, Deputy Fire Chief Arthur Whitenight, and Assistant Fire Chief Seth Heddings, Chief Zettlemoyer.

Following the Pledge of Allegiance and invocation, Mrs. Foust then administered the oath of office to Mayor Mr. Thomas Aber. Mayor Aber then administered the oaths of office to newly elected/reelected council members: Mrs. Meckley, Mr. Pfeil, Mrs. Mabus, Mrs. Moralez, and Mr. Derr. Mrs. Foust then administered the oaths of office to the newly elected Fire Chiefs – Department Chief Scott Derr, Deputy Chief Arthur Whitenight, and Assistant Chief Seth Heddings.

Election of Council President: Attorney Wiley called for nominations for the position of Council President. Mr. Pfeil nominated Mr. Walker; seconded by Mr. Derr. There were no additional nominations. Mr. Moralez moved to close the nominations, seconded by Mr. Pfeil, and carried; Mr. Walker was appointed President of Council.

President Walker then presided over the meeting.

Election of Council Vice President: Ms. Fawess nominated Mr. Moralez, seconded by Mr. Derr. There were no additional nominations. Mr. Scheimreif moved to close the nominations, seconded by Mrs. Mabus, and carried; Mr. Moralez was appointed Vice President of Council.

Appointment of Chairperson Pro-tem: Ms. Fawess nominated Mrs. Meckley, seconded by Mr. Moralez. Mr. Moralez made a motion to close the votes, seconded by Mr. Derr and carried; Mrs. Meckley was appointed as Chairperson Pro-tem.

Appointment of Vacancy Board Committee and Chairman: Motion was tabled until next meeting.

Appointment of Manager: On motion from Ms. Fawess, seconded by Mr. Derr and carried, Curt Zettlemoyer was appointed as Interim Borough Manager until April 25, 2026, at which time he is scheduled to retire as Chief and further discussions will be had.

Appointment of Secretary/Treasurer: On motion from Mr. Derr, Seconded by Mr. Pfeil, and carried Mrs. Foust was appointed as Borough Secretary/Treasurer.

Appointment of Code Enforcement/Zoning Officer: On motion of Mrs. Meckley, seconded by Mr. Scheimreif and carried, Alec Klingler was appointed as Borough Code Enforcement/Zoning Officer.

Appointment of Solicitor: On motion of Ms. Fawess, seconded by Mr. Pfeil and carried, Attorney J. Michael Wiley was appointed as Borough Solicitor.

Appointment of Sewage Enforcement Officer: On motion of Mrs. Meckley, seconded by Mr. Pfeil and carried, Council appointed Paul Rapp as the Borough's Sewage Enforcement Officer.

There being no other business to be considered at this meeting, on motion from Mrs. Meckley, seconded by Mr. Derr and carried, the meeting adjourned at 5:10 p.m.
