

**AN ORDINANCE OF THE BOROUGH OF MILTON, NORTHUMBERLAND COUNTY, PENNSYLVANIA, TO
VACATE AN UNNAMED ALLEY IN THE SECOND WARD OF THE BOROUGH OF MILTON.**

WHEREAS an application has been made to the Borough of Milton by the adjacent land owners to vacate the following unopened, unnamed fifteen (15) – foot - wide alley, situated in the Second Ward of the Borough of Milton, Northumberland County, Pennsylvania, and located between Tax Parcels # 032-02-002-080, 032-02-002-081 & 032-02-002-082 on the West of the unnamed alley and Tax Parcel # 032-02-002-079 & 032-02-002-078 on the East Tax Assessment Maps for the Borough of Milton.

WHEREAS the best interests of the citizens of Milton will be served by vacating the said unnamed alley.

BE IT ENACTED AND ORDAINED by the Borough Council of the Borough of Milton, Northumberland County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

BE IT from and after passage of this Ordinance, the following described unnamed alley situate in the Second Ward of the Borough of Milton:

Section 1 - A fifteen (15) – foot - wide unnamed alley two hundred and twenty (220) feet in length in the Second Ward located between Tax Parcels # 032-02-002-080, 032-02-002-081 & 032-02-002-082 on the west, and Tax Parcel # 032-02-002-079, 032-02-002-078 on the east, starting at a point from the western face of the curb at the northwest corner point of the Locust Street and Ash Street intersection; hence heading in a westerly direction, a distance of one hundred (100) feet to the northeast beginning point of the said unnamed alley, and the northwest corner point of Tax Parcel # 032-02-002-079; hence the vacating starting point on the eastern side of said unnamed alley and the eastern side of Tax Parcel # 032-02-002-079; hence continuing south along the portion of the said unnamed alley to be vacated, a distance of two hundred eighteen (218) feet to the vacating ending point on the eastern side of the said unnamed alley, the southwestern corner point of Tax Parcel # 032-02-002-078; hence continuing west a distance of fifteen (15) feet to a point on the west side of the unnamed said alley, a point on the east side of Tax Parcel # 032-02-002-082; hence continuing north along the west side of the said unnamed alley, a distance of two hundred twenty (220) feet to the northeastern corner point of Tax Parcel # 032-02-002-080 and the northwestern vacating point of the of said alley; hence continuing east, a distance of fifteen (15) feet to the northeastern vacating point of the said unnamed alley, the original vacating starting point of the unnamed alley be and the same is hereby vacated.

Section 2 – All other ordinances or portions thereof inconsistent herewith are hereby repealed.
