

ORDINANCE NO. 1263

AN ORDINANCE OF THE BOROUGH OF MILTON AMENDING AND UPDATING CHAPTER 233, VEHICLES AND TRAFFIC, OF THE CODIFIED ORDINANCES OF THE BOROUGH OF MILTON, TO INCLUDE, ARTICLE I – GENERAL PROVISIONS; ARTICLE II – TRAFFIC REGULATIONS; ARTICLE III – PARKING REGULATIONS; ARTICLE IV – REMOVAL AND IMPOUNDING OF CERTAIN VEHICLES; ARTICLE V – SNOW AND ICE EMERGENCIES AND REMOVAL OF VEHICLES OBSTRUCTING, IMPEDING OR HINDERING CERTAIN ACTIVITIES ON PUBLIC STREET, ALLEYS OR THOROUGHFARES; ARTICLE VI – MISCELLANEOUS PROVISIONS, TO INCLUDE ENFORCEMENT, VIOLATIONS, AND PENALTIES AND FINES; ARTICLE VII – METERED PARKING; ARTICLE VIII – SCHEDULES; ARTICLE IX – PARKING RESTRICTIONS; ARTICLE X – UNATTENDED VEHICLES ON PRIVATE PROPERTY; ARTICLE XI – PLACEMENT OF PERSONAL PROPERTY IN STREETS; AND, ARTICLE XII – MUNICIPAL PARKING LOTS.

WHEREAS, Borough Council of the Borough of Milton is acting to amend and update Chapter 233 of the Codified Ordinances of the Borough of Milton concerning vehicles and traffic;

WHEREAS, Ordinance No. 1263, as drafted, is a comprehensive amendment update to the provisions of the Codified Ordinances of the Borough of Milton; and,

WHEREAS, Ordinance No. 1263, as drafted, is intended to replace Chapter 233 of the Codified Ordinances of the Borough of Milton in full and the prior version of Chapter 233 will be repealed.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED AS FOLLOWS:

1. The amended version of Chapter 233 to be ordained and enacted by this Ordinance No. 1263 is attached hereto as Exhibit A and is incorporated by reference as though fully set forth herein.

2. The amended version of Chapter 233, as attached hereto as Exhibit A and as incorporated, is hereby ordained and enacted in full as the amended and replacement Chapter 233 of the Codified Ordinances of the Borough of Milton.

3. The prior version of Chapter 233 is hereby replaced and repealed in full.

4. Any and all ordinances and/or resolutions, or parts thereof, conflicting herewith are repealed insofar as the matters herein affected.



clause, sentence, subsection, or section rendered.

6. The effective date of this Ordinance shall take effect upon approval by the Borough Council.





ARTICLE I
General Provisions

§ 233-1. Definitions and interpretations.¹

- A. Words and phrases, when used in this ordinance, except for sections or articles to which different or additional definitions apply, shall have the meanings ascribed to them in the Vehicle Code, 75 Pa.C.S.A. 101 et seq. (the Act of June 17, 1976, P.L. 162, No. 81), as amended, except that in this chapter the word "street" may be used interchangeably with the word "highway" and shall have the same meaning as the word "highway" as defined in the Vehicle Code.
- B. The term "legal holidays," as used in this chapter, shall mean and include New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day.
- C. In this chapter, the singular shall include the plural, the plural shall include the singular, and the masculine shall include the feminine.

§ 233-2. Manner of adopting permanent traffic and parking regulations.

All traffic and parking regulations of a permanent nature shall be enacted as ordinances or as parts of ordinances or as amendments to ordinances or by resolution as allowed by specific sections of this chapter of the Borough of Milton.

§ 233-3. Temporary and emergency regulations.

- A. The Mayor or Borough Manager shall have the following powers to regulate traffic and parking temporarily and in time of emergency:
 - (1) In the case of fire, flood, storm or other emergency, to establish temporary traffic and/or parking regulations.
 - (2) In the case of emergency public works or public events of limited scope or duration, to restrict or prohibit traffic and/or parking in limited areas for periods of not more than 72 hours.
- B. These temporary and emergency regulations shall be enforced by the Mayor and the police in the same manner as permanent regulations. Any person who drives or parks a vehicle in violation of any such regulation or who shall move, remove, destroy, injure or deface any sign or marking erected, posted or made to give notice of any such regulation shall, upon conviction thereof, be liable to the penalty set forth in the law or elsewhere in this chapter for a violation of such nature.

§ 233-4. Experimental regulations.

- A. The Borough Council may, from time to time, designate places upon and along the streets in the Borough where, for a period of not more than 90 days, specific traffic and/or parking regulations, prohibitions and restrictions shall be in force and effect and shall designate those locations by proper signs and markings. Such regulations, prohibitions and restrictions shall be effective just as if they had been specified in this chapter. No person shall drive or park a vehicle in violation of any such regulation, prohibition or restriction, and no person shall move, remove, destroy or deface any sign or marking erected, posted or made by authority of this section. Any person who violates any

provision of this section shall, upon conviction, be liable to the penalty set out in the law or elsewhere in this chapter for a violation of such nature.

B. The purpose of this section is to allow for test and experimental determination of the feasibility and desirability of permanent changes in the ordinances of the Borough relative to traffic and parking.

§ 233-5. Streets closed or restricted for construction, maintenance or special events.

A. The Borough Manager shall have authority to close any street or specific part of a street to vehicular traffic and to place barriers or station police officers at each end of the closed portion, while construction or maintenance work is under way or a special event is being conducted on the closed portion. It shall be unlawful for any person to drive a vehicle upon any such closed portion.

B. The Borough Manager shall have authority to establish a restricted traffic area upon any street where construction or maintenance work is under way and to station flagmen at each end of the restricted portion. It shall be unlawful for any person to drive a vehicle upon any such restricted traffic area at any time when the flagman is displaying a sign directing that vehicle to stop or is signaling that vehicle, by a flag or other device, not to proceed.

§ 233-6. Authority of police officers.

The police shall have authority to direct traffic on the streets in the Borough, at intersections in public and in other places where the Vehicle Code or this chapter applies.

ARTICLE II
Traffic Regulations

§ 233-7. Speed limits.

The speed limit for both directions of traffic along the streets or parts thereof described in Schedule I (§ 233-46), attached to and made a part of this chapter, is hereby established at the rate of speed indicated in said schedule. It shall be unlawful for any person to drive a vehicle at a higher speed than the maximum prescribed for that street or part of a street.

§ 233-8. Traffic control signals.

Traffic control signals shall be installed and operated at the intersection of those streets described in Schedule II (§ 233-47), attached to and made a part of this chapter.

§ 233-9. Prohibited right turns on red signals.

No person shall make a right turn (or a left turn from a one-way street into another one-way street) when facing a steady red signal at any of the locations described in Schedule III (§ 233-48), attached to and made a part of this chapter.

§ 233-10. Prohibited turns at intersections.

It shall be unlawful for the driver of any vehicle to make a turn of the kind designated (left, right, all) at any of the intersections described in Schedule IV (§ 233-49), attached to and made a part of this chapter.

§ 233-11. U-turns.

It shall be unlawful for the driver of any vehicle to make a U-turn on any of the streets or parts of streets described in Schedule V (§ 233-50), attached to and made a part of this chapter.

§ 233-12. One-way streets.

The streets or parts of streets described in Schedule VI (§ 233-51), attached to and made a part of this chapter, are hereby designated as one-way streets in the direction indicated, and it shall be unlawful for any person to drive a vehicle on any one-way street other than in the direction established for traffic in that street.

§ 233-13. No-passing zones.

No-passing zones are hereby established along those streets or parts of streets described in Schedule VII (§ 233-52), attached to and made a part of this chapter, and it shall be unlawful for the driver of any vehicle to overtake or pass another vehicle or to drive on the left side of the roadway in any no-passing zone described in said schedule.

§ 233-14. Stop intersections.

The intersections described in Schedule VIII (§ 233-53), attached to and made a part of this chapter (in addition to intersections with the through streets established by this chapter), are hereby established as stop intersections, and official stop signs shall be erected in such a position upon the first-named street as to face traffic approaching the second-named street in the direction or directions indicated in said

schedule. Every driver of a vehicle approaching any such intersection upon the first-named street, in the direction or directions indicated in each case, shall come to a full stop before entering any such intersection. Stop intersections may be added or deleted from this chapter by resolution of the Borough Council. Any intersection added by resolution shall not become effective unless a stop sign is placed in the direction of travel indicated, and any intersection deleted by resolution shall not become effective until the stop sign is removed from the intersection indicated.

§ 233-15. Yield intersections.

The intersections described in Schedule IX (§ 233-54), attached to and made a part of this chapter (in addition to intersections with the through streets established by this chapter), are hereby established as yield intersections, and official yield signs shall be erected in such a position upon the first-named street as to face traffic approaching the second-named street in the direction or directions indicated. Every driver of a vehicle approaching any such intersection upon the first-named street, in the direction or directions indicated in each case, shall slow down or stop the vehicle and then yield the right-of-way to any vehicle in the intersection or approaching on the second-named street so closely as to constitute a hazard during the time that the driver is moving across or within such intersections.

§ 233-16. Closing of certain streets to certain vehicles.

- A. It shall be unlawful for any person to drive any vehicle, except a passenger vehicle (but not including any passenger vehicle drawing any trailer or towing any other vehicle), upon any of the streets or parts of streets described in Schedule X (§ 233-55), attached to and made a part of this chapter.
- B. It shall be unlawful for any person to drive any vehicle in excess of 45 feet in length, which includes the entire length of the motor vehicle and any trailer or other object which is being towed by or connected to the motor vehicle, upon any of the streets or portions of said streets within the Borough added to § 233-55B (identified as Schedule X). **[Added 7-25-2012 by Ord. No. 1178]**

§ 233-17. Vehicle weight limits.

It shall be unlawful for any person to drive any commercial vehicle or other tractor, trailer or tractor-trailer combination, having a gross weight in excess of that respectively prescribed, upon any of the streets or bridges, or portions thereof, described in Schedule XI (§ 233-56), attached to and made a part of this chapter, except for the purpose of making local deliveries on said streets.

ARTICLE III Parking Regulations

§ 233-18. Vehicles to be parked within marked spaces.

Wherever a space is marked off on any street for the parking of an individual vehicle, every vehicle parked there shall be parked wholly within the lines bounding that space, and it shall be a violation of this article for any person to park a vehicle or allow it to remain parked otherwise.

§ 233-19. Angle parking.

No person shall park a vehicle upon any of the streets or parts thereof described in Schedule XII (§ 233-57), attached to and made a part of this chapter, except at the angle designated and only within the painted stall lines. On all streets or portions thereof where angle parking is now or shall hereafter be authorized, all vehicles parked thereon shall be parked with the front thereof nearest the curb.

§ 233-20. Parking prohibited at all times.

No person shall park a vehicle at any time upon any of the streets or parts thereof described in Schedule XIII (§ 233-58), attached to and made a part of this chapter.

§ 233-21. Parking prohibited certain hours.

No person shall park a vehicle upon any of the streets or parts of streets described in Schedule XIV (§ 233-59), attached to and made a part of this chapter, during the hours specified in said schedule, on any day except Saturdays, Sundays and legal holidays.

§ 233-22. Time limit parking.

No person shall park a vehicle or allow the same to remain parked upon any of the streets or parts of streets described in Schedule XVI (§ 233-61), attached to and made a part of this chapter, between the hours specified, for longer than the time indicated in said schedule.

§ 233-23. Special purpose parking zones.

It shall be unlawful for any person to park any vehicle or to allow the same to remain parked in any special purpose parking zone established in Schedule XVII (§ 233-62), attached to and made a part of this chapter, except as specifically provided for such zone.

§ 233-24. Handicapped parking.

- A. The Borough is hereby authorized to designate by resolution certain parking places on the public streets of the Borough of Milton as reserved parking places for handicapped persons or severely disabled veterans in which the parking of any vehicle not displaying a handicapped or severely disabled veteran parking card, pursuant to the Pennsylvania Vehicle Code, as amended,² is prohibited.
- B. The said reserved places shall be indicated by a sign or signs indicating that the place is reserved for a handicapped person or severely disabled veteran.
- C. Any person violating the provisions of this section shall be subject to the penalty provisions of § 233-36.

§ 233-25. Penalties for parking violations.

Any person who violates any provision of this article shall be subject to the penalty provisions of § 233-36; provided, however, that it shall be the duty of the police officers and of parking enforcement personnel of the Borough to report to the Chief of Police all violations of any provision of this article, indicating, in each case, the section violated, the license number of the vehicle involved in the violation, the location where the violation took place and any other facts that might be necessary in order to secure a clear understanding of the circumstances attending the violation. The police officer or other person making the report shall also attach to or place upon every such vehicle a notice stating that the vehicle was parked in violation of this article. The notice shall contain instructions to the owner or driver of the vehicle that if he will report to the office of the Chief of Police and pay the sum indicated within 10 days after the time of the notice, or if he will place the sum, enclosed within the envelope provided, in the special parking fine box installed at the entrance to the Police Station, 1 Filbert Street, that act will save the violator from prosecution and from payment of the fine and costs prescribed in the first sentence of this section.

ARTICLE IV
Removal and Impounding of Certain Vehicles

§ 233-26. Applicability and scope.

This article is enacted under authority of Section 6109 (a)(22) of the Vehicle Code and gives authority to the Borough to remove and impound vehicles that are parked in violation on any street in the Borough, or in violation of any provision of this chapter.

§ 233-27. Authority to remove and impound.

The Borough shall have authority to remove and impound or to order the removal and impounding of any vehicle parked overtime or otherwise illegally, provided that the circumstances of its parking were within the conditions stated in § 233-26 of this article and provided that no such vehicle shall be removed or impounded except in strict adherence to the provisions of this article.

§ 233-28. Designation of approved storage; bonding; towing and storage.

Removal and impounding of vehicles under this article shall be done only by approved storage garages that shall be designated from time to time by the Borough Council. Every such garage shall submit evidence to the Borough Council that it is bonded or has acquired liability insurance in an amount satisfactory to the Borough Council as sufficient to indemnify owners of impounded vehicles against loss or damage to those vehicles while in the custody of the garagekeeper for the purpose of towing or storage. The approved storage garage shall submit to the Borough Council its schedule of charges for towing and storage of vehicles under this article, and when the schedule is approved by the Borough Council, those charges shall be adhered to by the approved storage garage. No different schedule of charges shall be adopted without approval of the Borough Council, and no different charges shall be demanded of or collected from any person whose vehicle is removed or impounded under this article by any approved storage garage. The Borough Council shall delete from its list of approved storage garages any garage that makes any unapproved charge in connection with any vehicle removed or impounded under this article.

§ 233-29. Notification of removal and impounding.

Within 12 hours from the time of removal of any vehicle under authority granted by this article, notice of the fact that the vehicle was removed shall be sent by the Borough to the owner of record of the vehicle. The notice shall designate the place from which the vehicle was removed, the reason for its removal and impounding and the garage in which it was impounded.

§ 233-30. Effect of payment of towing and storage charges.

The payment of any towing and storage charges authorized by this article shall, unless payment is made under protest, be final and conclusive and shall constitute a waiver of any right to recover the money so paid. If payment of any towing or storage charges is made under protest, the offender shall be entitled to a hearing before a District Justice. Payment of towing and storage charges shall not relieve the owner or driver of any vehicle from liability for any fine or penalty for the violation of the provision of this chapter for which the vehicle was removed or impounded.

§ 233-31. Records of vehicles removed or impounded.

The Borough shall cause a record to be kept of all vehicles impounded under this article and shall be able at all reasonable times to furnish the owners or the agents of the owners of those vehicles with information

as to the place of storage of the vehicle.

§ 233-32. Restrictions upon removal of vehicles.

No vehicle shall be removed under the authority of this article if, at the time of the intended removal, the owner or the person for the time being in charge of the vehicle is present and expresses a willingness and intention to remove the vehicle immediately.

ARTICLE V

Snow and Ice Emergencies and Removal of Vehicles Obstructing, Impeding or Hindering Certain Activities on Public Streets, Alleys or Thoroughfares
[Amended 4-26-2000 by Ord. No. 1117]

§ 233-33. Abandoned vehicles and vehicles which obstruct, impede or hinder traffic, salting, snowplowing, snow removal, repairs or construction on public streets, alleys or thoroughfares.

- A. Whenever any vehicle is found stalled, stuck, parked or abandoned on any Borough street, alley or thoroughfare in such a manner as to obstruct, impede or hinder traffic, salting, snowplowing, snow removal operations, repair or construction on public streets, alleys or facilities within the Borough of Milton, the vehicle shall be removed at the owner's expense.
- B. Such vehicles shall be removed only by persons authorized by the Borough Manager and approved by Borough Council. Such persons shall be notified by police of the removal of said vehicle. Police shall document the following information: type of vehicle, license number, place of removal, time of removal, cause of removal, place where the vehicle was removed to and any other information that may be required. The police shall attempt to notify the owner of such vehicle, as soon as reasonably possible, of the removal and location of such vehicle.

§ 233-34. Sidewalks; driveways; parking areas.

- A. It shall be unlawful for any person, when clearing sidewalks, private driveways or parking areas, to deposit snow on the streets or alleys of the Borough of Milton.
- B. It shall be unlawful for anybody other than Borough employees or contractors contracted by the Borough of Milton to plow snow on any public right-of-way within the Borough limits.

§ 233-35. Penalty for violation.

Any person who violates any of the provisions of this shall be subject to the penalty provisions of § 233-36.

Article VI
Miscellaneous Provisions

§ 233-36. Enforcement, violations, and penalties.

Unless another penalty is expressly provided by the Vehicle Code (75 Pa.C.S.A. § 101 et seq.) or except as specified within the Borough's Ordinances, the enforcement of penalties for violations of Chapter 233 of the Borough's Codified Ordinances shall be in accordance with this Section.

A. Violation penalty amounts.

- (1) A parking violation ticket, in the following amount, shall be issued for any violation of a provision of this Chapter.
 - i. Violations of Section 233-64 – Stopping, Standing, and Parking, are subject to a \$15.00 parking violation ticket;
 - ii. Violations of Section 233-24 – Handicapped Parking, are subject to a \$50.00 parking violation ticket;
 - iii. All other violations of this Chapter are subject to a \$20.00 parking violation ticket.

B. Enforcement authority and action.

- (1) It shall be the duty of the Milton Police Department and parking enforcement personnel of the Borough to issue parking violation tickets for violations of this article in accordance with the Pennsylvania Rules of Criminal Procedure and Borough ordinances.
- (2) Violation tickets shall include the date and hour of the violation, the license number of the vehicle involved in the violation, the location where the violation occurred, and other facts relevant and necessary for a thorough understanding of the circumstances attending the violation and to substantiate any subsequent additional legal enforcement attending the violation. The notice shall also include a statement that the vehicle was parked in violation of this article and instructing the owner of the vehicle that if the sum specified by resolution of Borough Council is enclosed in the envelope provided and delivered to the Milton Police Department within 10 days after the date of the notice, that payment will prevent additional penalties and/or prosecution with regard to this violation.
- (3) In the absence of a vehicle owner or operator being available for service of the ticket, the parking enforcement personnel or police officer shall attach the violation notice upon the vehicle.
- (4) Failure to pay the stated violation penalty within 10 days of the issuance of the ticket shall result in the Borough having the option, in its sole discretion, to the following enforcement action:
 - i. Any person, partnership, association, organization, corporation or other business entity who violates any provision of this ordinance shall pay a civil penalty of not more than six hundred dollars (\$600.00). The enforcement of this ordinance shall be by action brought before a district magistrate in the same manner as provided for the enforcement of civil actions. Each and every day of continued violation and each specific violation shall constitute a separate violation of this ordinance; or
 - ii. Any person, partnership, association, organization, corporation or other business entity who violates any provision of this ordinance shall be guilty of an offense; and, for every such violation, upon conviction, shall be sentenced to pay a fine of not more than one thousand dollars (\$1,000.00) and costs of prosecution; and, in default of payment of fine and costs, to undergo imprisonment for not more than thirty (30) days. The

enforcement of this ordinance shall be by action brought before a district magistrate in the same manner as provided for the enforcement of offenses under the Pennsylvania Rules of Criminal Procedure. The municipal solicitor may assume charge of the prosecution without the consent of the district attorney as required under Pa.R.Crim.P. No. 454 (relating to trial in summary cases). Each and every day of continued violation and each specific violation shall constitute a separate violation of this ordinance.

- iii. In addition to the foregoing civil penalty or fine, the District Magistrate may assess court costs and reasonable attorney's fees incurred by the Borough in the enforcement proceedings.
- iv. If a civil claim under subsection (a), exclusive of interest, costs or fees, exceeds the monetary jurisdiction of a magisterial district judge under 42 Pa.C.S. § 1515(a) (relating to jurisdiction and venue), the Borough may: (i) bring the action in a court of common pleas; or (ii) make a waiver under 42 Pa.C.S. § 1515(a)(3).
- v. In addition to or in lieu of enforcement provided hereinunder in section (a) or (b), the Borough may enforce this Ordinance in equity with the filing for injunctive relief before the Court of Common Pleas of Northumberland County, Pennsylvania.

C. Additional violations.

- (1) It shall constitute a violation of this article for any person to display a falsified or altered parking permit at any time in a vehicle parked in a municipal parking lot.
- (2) It shall constitute a violation of this article for any person to falsely represent himself or herself as eligible for a parking permit or to furnish false information in an application to the Police Chief of the Milton Police Department or designee in order to obtain a parking permit.

D. Removal of vehicles in violation.

In accordance with applicable state law and Borough Ordinances, vehicles parked in violation of this article may be removed by towing, the cost of which shall be the responsibility of the vehicle owner. Nothing in this section shall preclude the ticketing of unlawfully parked vehicles as provided in this article or the penalization of the owner thereof as provided in this article.

§ 233-36.1. Fines, penalties, and permit fees by resolution. [Added 10-26-2022 by Ord. No. 1241]

Borough Council shall be empowered to set, modify, change, or otherwise alter any fine, penalty or permit fee established under this Chapter 233 by resolution of Borough Council.

Article VII
Metered Parking

§ 233-37. Designation of parking spaces.

The Borough Manager is hereby directed and authorized to provide for the marking off of individual parking spaces in the parking meter zones designated and described in Schedule XVIII (§ 233-63), said parking spaces to be designated by lines painted or marked on the curbing or surface of the street or lot. At each space so marked off, it shall be unlawful to park any vehicle in such a way that said vehicle shall not be entirely within the limits of the space so designated.

§ 233-38. Installation of parking meters.

In said parking meter zones, the Borough Manager shall cause parking meters to be installed upon the curb,

sidewalk or area immediately adjacent to the parking spaces provided in this article. The Chief of Police shall be responsible for the regulation, control, operation, maintenance and use of such parking meters. Each device shall be so set as to display a signal showing legal parking upon the deposit of the appropriate coin, lawful money of the United States of America, for the period of time prescribed in this article. Each device shall be so arranged that upon the expiration of the lawful time limit, it will indicate by a proper, visible signal that the lawful parking period has expired, and in such case the right of such vehicle to occupy such space shall cease, and the operator, owner, possessor or manager thereof shall be subject to the penalties hereinafter provided.

§ 233-39. Operation of parking meters.

Except in a period of emergency determined by an officer of the Fire or Police Department, or in compliance with the directions of a police officer or traffic control sign or signal, when any vehicle shall be parked in any parking space alongside or next to which a parking meter is located, the operator of such vehicle shall, upon entering the said parking meter space, immediately deposit or cause to be deposited in said meter such proper coin of the United States of America as is required for such parking meter and as is designated by proper directions on the meter, and when required by the directions on the meter, the operator of such vehicle, after the deposit of the proper coin, shall also set in operation the timing mechanism on such meter in accordance with directions properly appearing thereon, and failure to deposit such proper coin and to set the timing mechanism in operation when so required shall constitute a violation of this article. Upon the deposit of such coin (and the setting of the timing mechanism in operation when so required), the parking space may be lawfully occupied by such vehicle during the period of time which has been prescribed for the part of the street in which said parking space is located, provided that any person placing a vehicle in a parking meter space adjacent to a meter which indicates that unused time has been left in the meter by the previous occupant of the space shall not be required to deposit a coin so long as his occupancy of said space does not exceed the indicated unused parking time. If said vehicle shall remain parked in any such parking space beyond the parking time limit set for such parking space and if the meter shall indicate such illegal parking, then and in that event such vehicle shall be considered as parking overtime and beyond the period of legal parking time, and such parking shall be deemed a violation of this article.

§ 233-40. Manner of parking.

When a parking meter space is parallel with the adjacent curb or sidewalk, no person shall park or permit the parking of any vehicle in such parking spaces in any other position than with the foremost part of such vehicle nearest to the parking meter; when a parking meter space is diagonal to the curb or sidewalk, no person shall park or permit the parking of any vehicle in such parking space in any other position than with the foremost part of such vehicle nearest to the parking meter; when a parking meter shall have been installed at the head of and immediately adjacent to any parking space on a municipal off-street parking lot, no person shall park or permit the parking of any vehicle in such parking space in any other position than with the foremost part of such vehicle nearest to the parking meter; provided, however, that in municipal off-street parking lots, signs shall be erected indicating that head-on parking only is permitted. In any event, a vehicle shall be parked within the lines marked on the pavement measuring such parking space.

§ 233-41. Violations.

It shall be unlawful and a violation of the provisions of this article for any person to:

- A. Cause, allow, permit or suffer any vehicle registered in the name of or operated by such person to be parked overtime or beyond the period of legal parking time established for any parking meter zone as herein described, or to deposit in any parking meter any coin for the purpose of parking beyond the maximum legal parking time for that particular parking meter zone.
- B. Permit any vehicle to remain or be placed in any parking space adjacent to any parking meter while said meter is displaying a signal indicating that the vehicle occupying such parking space has already been parked beyond the period prescribed for such parking space.

- C. Park any vehicle across any line or marking of a parking meter space or in such position that the vehicle shall not be entirely within the area designated by such lines or markings.
- D. Deface, injure, tamper with, open or willfully break, destroy or impair the usefulness of any parking meter installed under the provisions of this article.
- E. Deposit or cause to be deposited in any parking meter any slug, device or metal substance or other substitute for lawful coins.
- F. Park or permit the parking of any vehicle in any parking meter space where the meter does not register lawful parking.

§ 233-42. Reports of violations; citations.

- A. It shall be the duty of the police officers, or parking enforcement personnel, acting in accordance with instructions issued by the Chief of Police, to report:
 - (1) The number of each parking meter post which indicates that the vehicle occupying the parking space adjacent to such parking meter post is or has been parked in violation of any of the provisions of this article.
 - (2) The state license number of such vehicle.
 - (3) That such vehicle is parked in violation of any of the provisions of this article.
 - (4) Any other facts or knowledge of which is necessary to a thorough understanding of the circumstances attending such violation.
- B. Each such police officer shall also attach to such vehicle a notice to the owner thereof that such vehicle has been parked in violation of a provision of this article and instructing such owner as to the method of paying the fine indicated on the notice.

§ 233-43. Impounding of vehicles.

Any vehicle left parked for a period exceeding 24 hours succeeding expiration of the maximum parking time indicated during the hours of operation specified in the space in which the vehicle is parked may be towed, under the direction of the Police Department, to the place designated by the Chief of Police for impoundment, subject to redemption by the owner upon payment of the reasonable cost of towing and a storage charge for each day or portion thereof during which it remains in said garage or other place.

§ 233-44. Purpose of meter deposits.

The coins required to be deposited in parking meters as provided herein are hereby levied and assessed as fees to provide for the proper regulation and control of traffic upon the public streets and also the cost of supervising and regulating the parking of vehicles in the parking meter zones created thereby, and to cover the cost of the purchase, supervision, protection, inspection, installation, operation and maintenance of the traffic control devices throughout the Borough or any other purpose designated by the Borough Council.

§ 233-45. Collection of coins from meters; disposition thereof.

It shall be the duty of the Chief of Police to designate some proper person or persons to make regular collections of the moneys deposited in said meters, and it shall be the duty of such person or persons so designated to remove from the parking meters the locked containers therein containing the coins so deposited in said meters and to deliver such locked containers to the depository, who shall unlock them and count the funds contained in such containers and deposit such funds in the usual manner provided by law.

ARTICLE IX
Parking Restrictions

§ 233-64. Stopping, standing and parking restrictions; violations and penalties.

A. Except where necessary to avoid conflict with other traffic or to protect the safety of any person or vehicle or in compliance with law or the directions of a police officer or official traffic control devices, no person shall:

- (1) Stop, stand or park a vehicle:
 - (a) On the roadway side of any vehicle stopped or parked at the edge of a street, except that a pedalcycle may be parked abreast of another pedalcycle or pedalcycles.
 - (b) On a sidewalk, except that a pedalcycle may be parked on a sidewalk so long as it does not impede the normal and reasonable movement of pedestrians or other traffic.
 - (c) Within the intersection.
 - (d) On a crosswalk.
 - (e) Between a safety zone and the adjacent curb within 30 feet of point on the curb immediately opposite the end of a safety zone unless a different length is indicated by official traffic control devices.
 - (f) Along or opposite any street excavation of obstruction when stopping, standing or parking would obstruct traffic.
 - (g) Upon any bridge or other elevated structure upon a highway or within a highway tunnel.
 - (h) On any railroad tracks presently used.
 - (i) At any place where official signs prohibit stopping, standing or parking.
 - (j) Sycamore Lane, both sides, beginning at the face of curb on King Street at the King Street and Sycamore Lane intersection on both the southwestern and southeastern sides of Sycamore Lane and heading in a southerly direction a distance of 85 feet. **[Added 4-25-2018 by Ord. No. 1217]**
 - (k) Sycamore Lane, both sides, beginning 85 feet south of the curb on King Street and heading in a southerly direction a distance of 1,120 feet between the hours of 7:00 a.m. and 9:00 a.m. and between the hours of 2:00 p.m. and 4:00 p.m., Monday through Friday of each week, excepting the days between June 15 and August 15 of each year. **[Added 4-25-2018 by Ord. No. 1217]**
 - (l) Sycamore Lane, both sides, beginning at the face of curb on Old Orchard Road and Sycamore Lane intersection on both the southwestern and southeastern sides of Sycamore Lane and heading in a northerly direction a distance of 95 feet. **[Added 4-25-2018 by Ord. No. 1217]**
- (2) Stand or park a vehicle:
 - (a) In front of a public or private driveway.
 - (b) Within 30 feet upon the approach of any flashing signal, stop sign, yield sign or traffic

control signal located at the site of a roadway.

- (c) Within 20 feet of the driveway entrance to any fire station or, when properly sign posted, on the side of a street opposite the entrance to any fire station within 75 feet of the entrance.
- (d) Where the vehicle would prevent the free movement of traffic.
- (e) Within 15 feet of a fire hydrant.
- (f) Within 20 feet of an intersection.

(3) Park a vehicle within 50 feet of the nearest rail of a rail crossing presently in use.

B. Every vehicle standing or parked upon a two-way highway shall be positioned parallel to and with the right-hand wheels within 12 inches of the right-hand curb or in the absence of a curb, as close as practicable to the right edge of the right-hand shoulder, except as provided in § 233-19.

C. Every vehicle standing or parked upon a one-way highway shall be positioned parallel to the curb or edge of the highway in the direction of authorized traffic movement with its right-hand wheels within 12 inches of the right-hand curb or, in the absence of a curb, as close as practicable to the right edge of the right-hand shoulder, or with its left-hand wheel within 12 inches to the left-hand curb or, in the absence of a curb, as close as practicable to the left edge of the left-hand shoulder.

D. **Parking of oversized vehicles prohibited. [Added 2-8-2006 by Ord. No. 1156⁴]**

- (1) No person shall park a vehicle, except as provided in Subsection D(2) hereof, at any time upon any of the public streets, alleys or public rights-of-way within the Borough of Milton, that exceeds any one of the following dimensions: length, 20 feet; width, seven feet; height, eight feet.
- (2) **Exceptions.** The following vehicles are exceptions to the above prohibition:

 - (a) Vehicles may be parked temporarily for the purpose of and while actually engaged in the loading or unloading of personal property and/or passengers for a time period not to exceed three hours.
 - (b) Passenger vehicles which are modified for handicapped accessibility, provided that they are placed in a properly-marked reserve parking area for handicapped persons or severely-disabled veterans.
 - (c) Moving vans while actively engaged in the loading or unloading of personal property in or out of a property.

E. **Penalty.** Any individual or entity determined to be in violation of the provisions of this Article IX by the Milton Borough Police Department or designated authority or agency shall be subject to the penalty provisions of § 233-36. In addition: **[Amended 2-8-2006 by Ord. No. 1156]**

4. **Editor's Note:** This ordinance also redesignated former Subsection D as Subsection E.

- (1) Failure to remove a vehicle found to be in violation of this Article IX within 24 hours will be construed as an additional violation.
- (2) Any vehicle left parked in violation of this Article IX for a period exceeding twenty-four (24) hours after the violation notice is applied may be towed, under the direction of the Milton Borough Police Department or designated agency or authority, to the place designated by the Chief of Police for impoundment, subject to redemption by the owner upon payment of the reasonable cost of towing and storage charge for each day or portion thereof which it remains in said designated place.

ARTICLE X
Unattended Vehicles on Private Property

§ 233-65. Unattended vehicle on private property; violations and penalties.

- A. No person shall park or leave unattended a vehicle on private property without the consent of the owner or other person in control or possession of the property except in the case of emergency or disablement of the vehicle, in which case the operator shall arrange for the removal of the vehicle as soon as possible.
- B. The provisions of this subsection shall not apply to private parking lots unless such lots are posted to notify the public of any parking restrictions and the operator of the vehicle violates such posted restrictions. For the purpose of this section, "private parking lot" means a parking lot open to the public or used for parking without charge; or a parking lot used for parking with charge. The department shall define by regulation what constitutes adequate posting for public notice.
 - (1) Property owner may remove vehicle. The owner or other person in charge or possession of any property on which a vehicle is parked or left unattended in violation of the provisions of § 233-66 may remove or have removed the vehicle at the reasonable expense of the owner of the vehicle. Such person who removes a vehicle left unattended in violation of the provisions of § 233-66 shall have a lien against the owner of the vehicle, in the amount of the reasonable value of the costs of removing the vehicle. Any city, borough, incorporated town or township may, by ordinance, provide rates to be charged for removal of vehicles and for municipal regulation of authorized towing services.
 - (2) Restrictions by appropriate authorities. The department on state-designed highways and local authorities on any highway within their boundaries may by erection of official traffic control devices prohibit, limit or restrict stopping, standing or parking of vehicles on any highway where engineering and traffic studies indicate that stopping, standing or parking would constitute a safety hazard or where the stopping, standing or parking of vehicles would unduly interfere with the free movement of traffic.
 - (3) Penalty. Any person violating any provisions of this section shall be subject to the penalty provisions of § 233-36.

ARTICLE XI
Placement of Personal Property in Streets
[Added 2-8-2006 by Ord. No. 1156]

§ 233-66. Definitions.⁵

As used in this article, the following terms shall have the meanings indicated:

IMPROVED SURFACE — The area between the curbs of a public street or alley, and if no curbs are installed, then the area which is paved or on which vehicles normally travel or are parked.

PERSONAL PROPERTY — Shall include, but shall not be limited to, athletic equipment, trailers, campers, storage or refuse containers, bicycles, toys, furniture and any other type of personal property not approved by the Borough of Milton.

§ 233-67. Placement of personal property restricted.

- A. No personal property, except for properly-licensed motor vehicles with visible proof of current registration and inspection and items excepted in § 233-68 hereof, shall be permitted to be placed, stored, or parked on the improved surface of any public street or alley, since such items pose a hazard and hindrance to motor vehicles, street cleaning, snow removal, brush and leaf removal, maintenance operations, and stormwater drainage.
- B. Exceptions. Storage of certain personal property used in construction, demolition or maintenance purposes shall be permitted to be stored in the said public streets or alleys provided written permission is obtained from the Borough Manager prior to placement of the item there, and placement is in accordance with the Borough Manager's instructions. These shall include dumpsters, construction offices, storage trailers, construction equipment, and similar items necessary for the aforesaid purposes.
- C. Violations and penalties.
 - (1) Any person violating the provisions of this section shall be subject to the penalty provisions of § 233-36.
 - (2) Any such property in violation of this Article XI deemed by the Borough of Milton to create an imminent danger to persons and property, or an obstruction to the necessary operations of the Borough, may be removed by employees of the Borough of Milton, or its designated authority or agency, and the costs of such removal shall be levied against the property owner. Failure to pay removal costs may result in additional prosecution, prosecution costs, court costs, and in default of payment of said costs, imprisonment for a period of not more than 30 days.

ARTICLE XII
Municipal Parking Lots
[Added 9-9-2015 by Ord. No. 1199]

§ 233-68. General purpose.

The Borough of Milton currently has three primary parking lots which are utilized by the public, Borough employees, and officials. The Borough Council has determined to enact the following regulations regarding the use and activities permitted within these lots and other properties owned by the Borough in which parking areas are available.

§ 233-69. Establishment of municipal parking lots.

The following municipal parking lots are established:

- A. Parking Lot No. 1: A municipal parking lot located in the Milton commercial business district and bordered on the west by Elm Street; the north by Cherry Alley; the east by Bound Avenue and the south by Center Street.
- B. Parking Lot No. 2: A municipal parking lot located south of the Police Station and beginning at the electric pole located at the northwest corner of the parking lot, heading in a southerly direction a distance of 108 feet to an electric pole located at the southwest corner of the parking lot, from there heading in an easterly direction a distance of 80 feet to the southeast corner of the parking lot, then heading in a northerly direction a distance of 108 feet to the northeast corner of the parking lot, then heading in a westerly direction a distance of 80 feet to the electric pole located at the northwest corner of the parking lot.
- C. Parking Lot No. 3: A municipal parking lot located south of the Borough Hall and beginning at the northeast corner of the intersection of the first alley south of the Borough Hall and Filbert Street, then heading in a westerly direction a distance of eight feet to the southeast corner of the public lot, then heading in a northerly direction along Filbert Street a distance of 20 feet to the northeast corner of the parking lot, then heading in a westerly direction a distance 87 feet to the northwest corner of the parking lot, then heading in a southerly direction a distance of 20 feet to the southwest corner of the parking lot, then heading in an easterly direction along said alley a distance of 87 feet to the southeast corner of the parking lot.

§ 233-70. Parking restricted during certain hours.

With the exception of official Borough or authorized Borough employee vehicles, no vehicles shall be parked in Parking Lot No. 1, No. 2 and/or No. 3 between the hours of 2:00 a.m. and 5:00 a.m., unless a permit is issued for the vehicle to be located in the respective parking lot during those hours.

§ 233-71. Metered or unmetered parking.

It shall be at the discretion of the Milton Borough Council to determine whether all or any portion of Parking Lot No. 1, 2, or 3, shall have parking meters installed. Such determination may be made by Milton Borough Council and established by adoption of a resolution making that designation. Meter rates shall be established from time to time by Council and adopted in the form of a resolution. A vehicle parked in a metered space at which the metered time has expired will be in violation of this article, and vehicles parked in a metered parking lot shall be in violation of this article if they are not in compliance with the requirements of Borough Ordinance Article VII, Metered Parking (§§ 233-37 to 233-45), of the Code of

Ordinances of the Borough of Milton, and will be subject to the enforcement and violation penalties of this article.

§ 233-72. Prohibition against obstructing or endangering parking lot access and use.

No individuals shall sit or stand in the areas of the parking lot designated for vehicular traffic and parking and/or participate in any activity which would hinder or obstruct the safe ingress or egress or movement of vehicles within the parking lot, or pose a danger to the personal safety of those participating or those utilizing the parking lot for parking, unless such activity is in conjunction with an event or activity approved by the Milton Borough Council.

§ 233-73. Delineation of parking spaces within municipal parking lots.

- A. Parking Lot No. 1. Lines and/or markings may be placed upon the surface of the parking lot, for the purpose of delineating each parking space. Every vehicle is required to be parked in such a manner as to be wholly within the lines or markings so placed and applicable to that space.
- B. Parking Lots Nos. 2 and 3. In the event that Parking Lots Nos. 2 and 3 remain unpaved and unlined, parking areas will be established as determined by the Borough Manager, and appropriate signage will be placed in the parking lot to indicate where and how vehicles are to be parked.
- C. Unauthorized parking areas. With the exception of authorized Borough or Borough employee-owned vehicles, all parking is prohibited on any other properties owned by the Borough in which parking areas are available unless expressly permitted by signage.
- D. Restricted parking by order of Borough Council, the Borough Manager, the Milton Police Department, or the Mayor. Borough Council, the Borough Manager, the Milton Police Department, or the Mayor, may, at their discretion, restrict parking in the municipal parking lots for the purposes of facilitating special events or activities approved by the Borough Council, or emergency or other situations.
- E. Violation. Vehicles not parked in compliance with this section will be in violation of this article and subject to the penalties as stated within and may be towed at the vehicle owner's expense.

§ 233-74. Handicapped parking spaces.

- A. In compliance with state or federal regulations, the Borough Council will provide by resolution, at convenient and suitable locations in any one or more of the metered or unmetered parking lots, reserved parking spaces designated for handicapped parking, and shall designate those spaces by appropriate signage.
- B. It shall be unlawful and a violation of this article for any person to park in any such reserved parking space any vehicle unless that vehicle bears or displays either a "handicapped registration plate," a "handicapped parking placard," a "disabled veteran registration plate," or "a disabled veteran placard."

§ 233-75. Reserved spaces for M&T Bank employees and customers and employees of the District Justice's Office No. 08-3-02. [Amended 1-25-2017 by Ord. No. 1209]

- A. In Parking Lot No. 1, there are several designated spaces that are reserved for the employees of M&T Bank which have been set aside due to M&T Bank's conveyance of certain land to the Borough to accomplish renovation of the parking lot. Those spaces are reserved strictly for M&T Bank

employees and customers at no cost or charge to M&T Bank. All other persons are prohibited from parking in those spaces that are so designated.

B. Vehicles that are not parked in compliance with this section will be in violation of this chapter and subject to the penalties stated within. Prior adopted ordinances establishing any other reserved parking spaces within the Borough-owned parking lots are hereby repealed.

§ 233-76. Parking lot permit parking.

A. Establishment of parking permit program. Establishment: There is hereby established a parking permit program for Municipal Parking Lot No. 1, Municipal Parking Lot No. 2, and Municipal Parking Lot No. 3. The permit is for use only in any of the parking spaces in the aforesaid parking lots and guarantees to the holder that they will have a parking space during the hours specified in § 233-70, but not a particular parking space in the said lot.

B. Parking permit application; fees; issuance.

- (1) Application for a parking permit shall be made to the Milton Police Department, by the person desiring the permit. The applicant shall be a registered owner or licensed driver of the motor vehicle to be permitted. Each application shall contain the following information: the name, address and telephone number of the applicant; the make, model, VIN, and license plate number of the motor vehicle to which the permit shall apply. The applicant shall be required, at the time of making application, to present a current driver's license, vehicle registration card, and valid vehicle insurance card. Vehicles must have a current vehicle inspection sticker and registration sticker and license plate appropriately displayed on the vehicle.
- (2) Each application shall be accompanied by a permit fee, as established from time to time by resolution of Borough Council. Permit fees shall be payable in advance. Permit fee revenues shall be for the use of the Borough to defer the cost of administering the parking permit program.
- (3) The maximum number of applications available for each municipal parking lot shall be established by resolution of the Borough Council.
- (4) Issuance of permit. Upon receipt of the application and the applicable permit fee, and after determination by the Police Chief of the Milton Police Department, or designee, that the information contained in the application shows that the applicant has fulfilled the requirements for a parking permit, the Police Chief of the Milton Police Department, or designee, shall issue to the applicant a parking permit valid for a period not to exceed 12 months. The permit shall display an assigned permit number and or such other information as required by the Police Chief of the Milton Police Department or his designee, and also display the expiration date of the permit or in the alternative, a color code or other code for the expiration date.
- (5) Display of permit. The parking permit must be visibly displayed on the dash of the vehicle whenever it is parked in the designated municipal parking lot during the time period for which it is required.

- (6) Permit renewal. The permit shall be renewable monthly, quarterly, semiannually, or annually or for such period of time as shall be determined from time to time by resolution of Borough Council. Renewal must be complete prior to the expiration date. The person renewing a parking permit must provide the same information required for the issuance of the original permit.
- (7) Parking permits are nontransferrable. The permit is only valid for the vehicle to which it was originally issued. Should the ownership of the vehicle change, the permit shall become invalid.
- (8) Revocation of permits. The Chief of Police of the Milton Police Department or designee shall have the authority to revoke a parking permit if the person to whom the parking permit is issued is found to be in violation of any provision of this article. Upon written notification of such revocation, the permit holder shall surrender the permit to the Police Chief of the Milton Police Department or designee. Failure to surrender the revoked parking permit shall constitute a violation of this article.
- (9) Appeal to Borough Council. Any person receiving notification of a revoked parking permit may, within 10 days of receipt of the notification, request a hearing before Borough Council to appeal the decision to revoke the parking permit. The decision of Borough Council shall be final.

§ 233-77. Enforcement; violations and penalties.

All violation fines and penalties shall be in accordance with Section 233-36 of this Ordinance.
